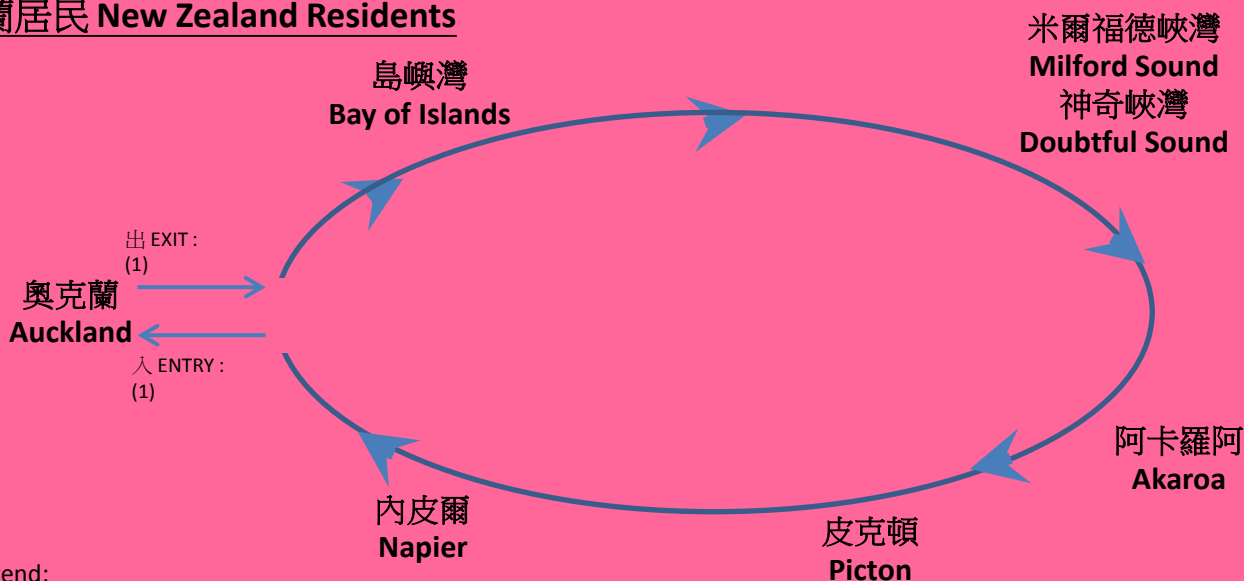

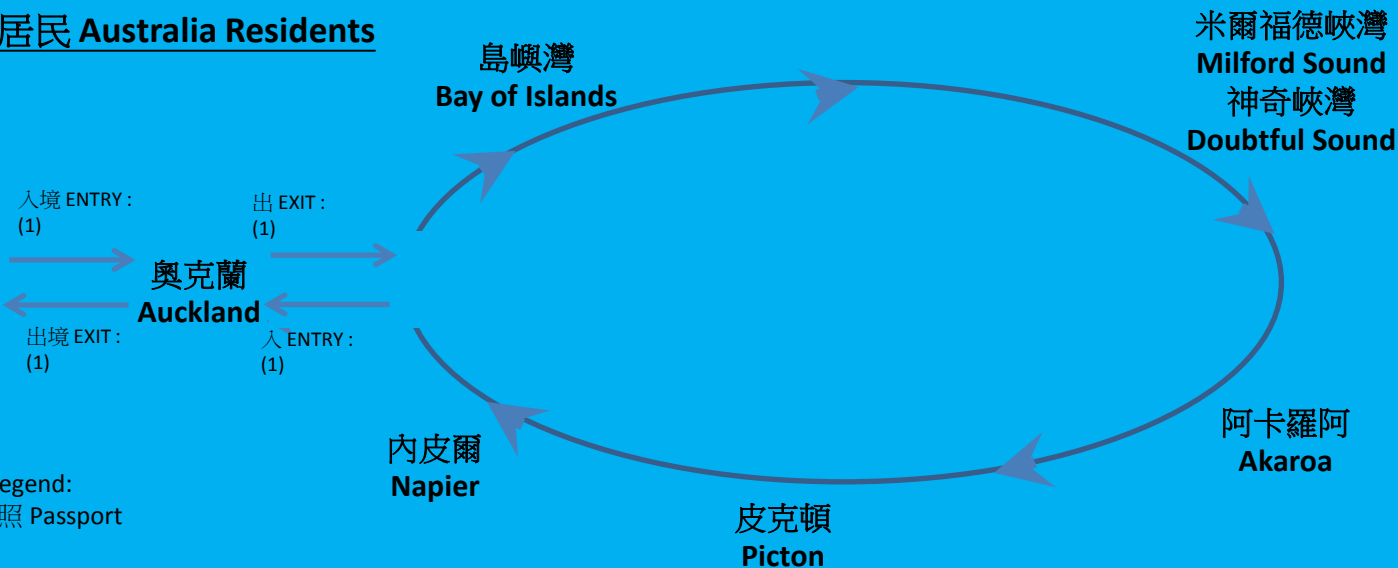

(1) 護照 Passport / 附有相片的身分證明文件正本 Original Identity document bearing photograph

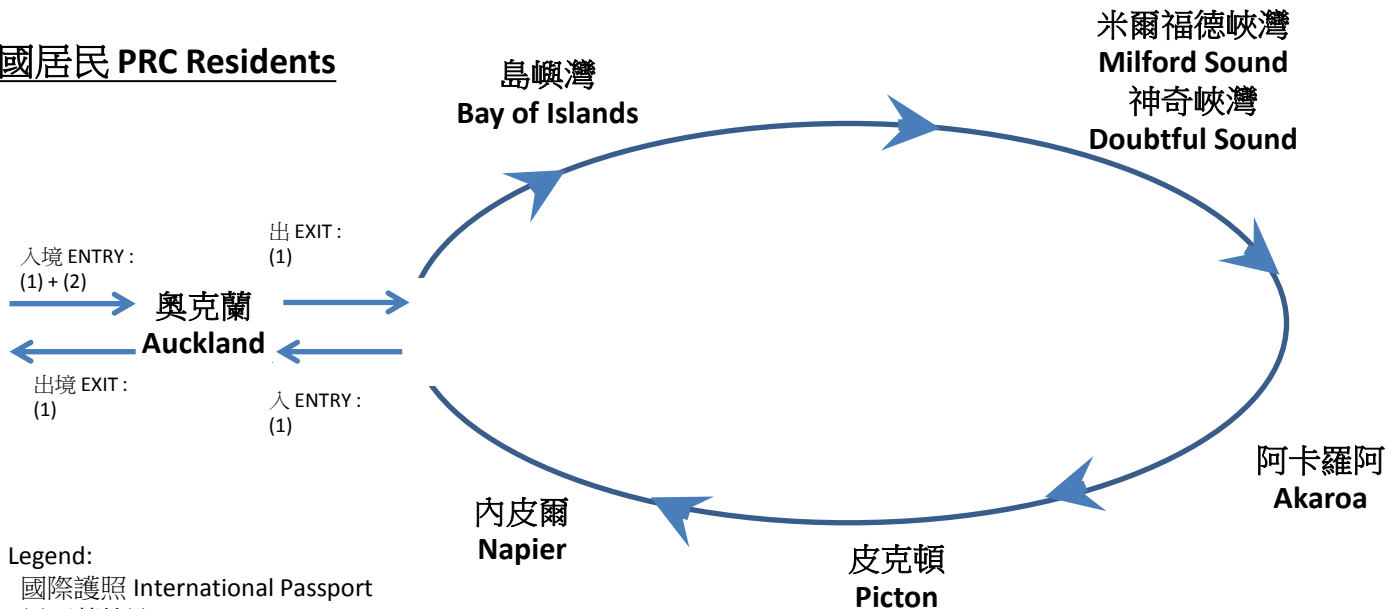
**澳洲居民 Australia Residents**

(1) 國際護照 International Passport

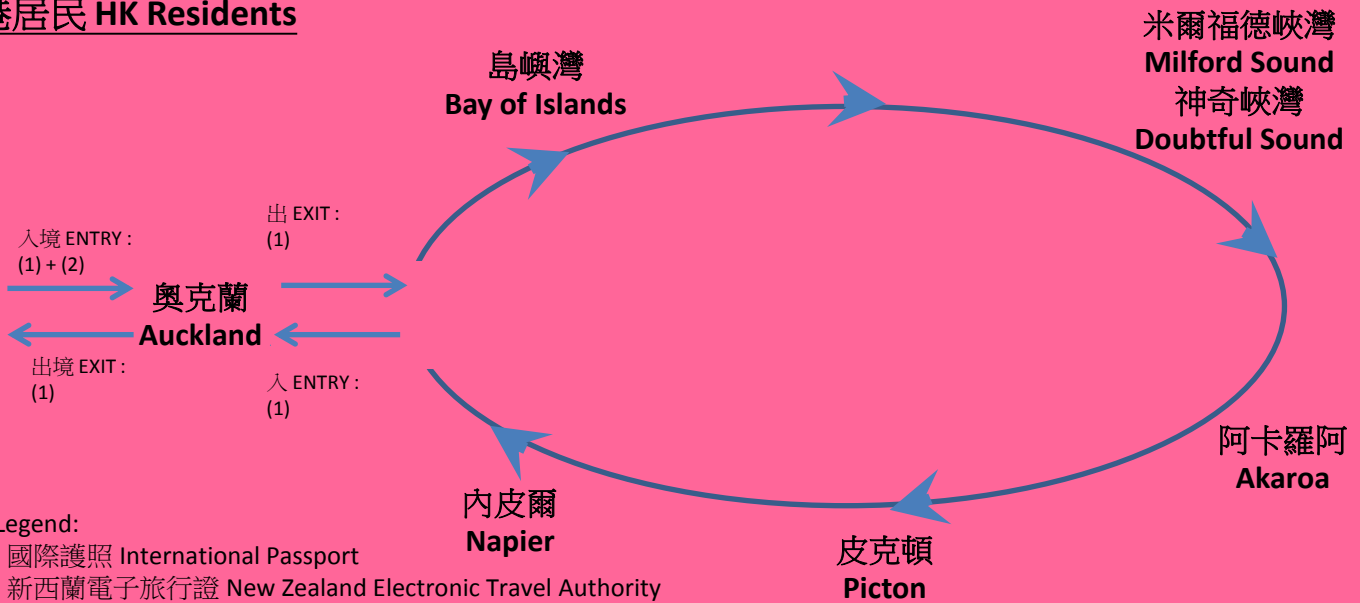

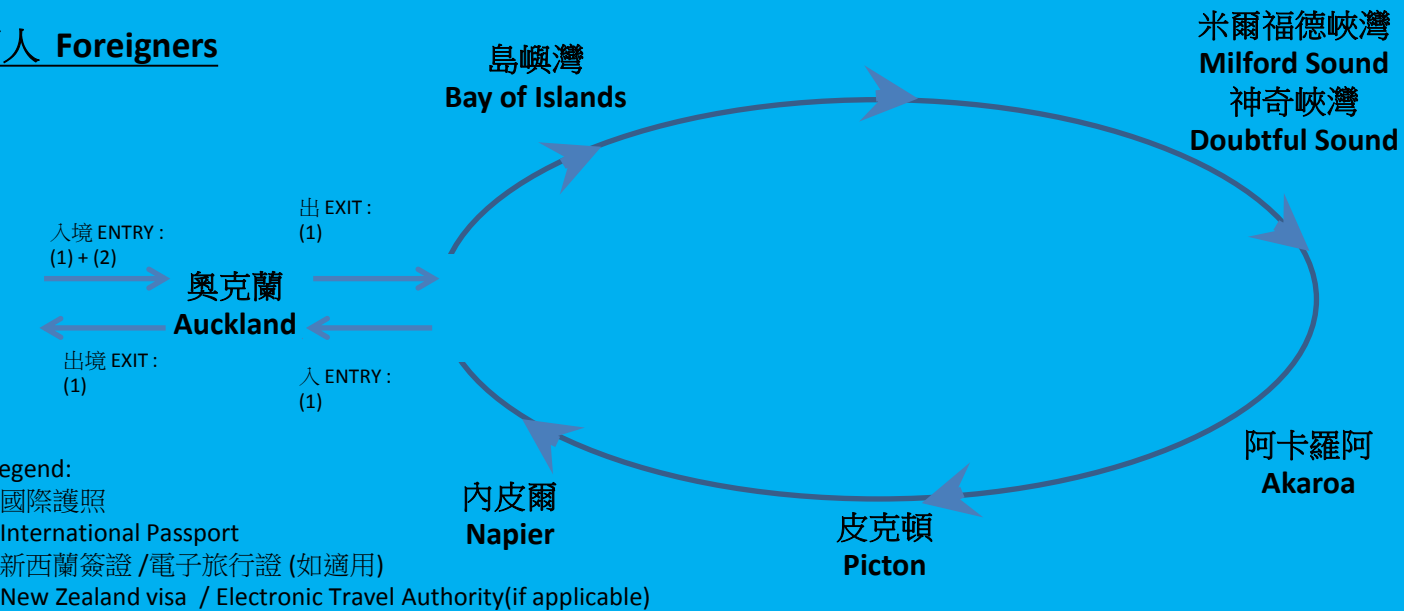

### Visiting New Zealand

A. International visitor levy (IVL) to be introduced in the middle of 2019 would be collected through visa fees and a new electronic travel authority.

The main parts of the Levy include:

- Most international visitors entering New Zealand for 12 months or less will be charged a levy of \$35. There will be some exemptions, most notably Australian citizens and permanent residents and people from many Pacific Island countries.
- The levy will be collected alongside visa and Electronic Travel Authority fees (Levy fee and ETA fee is subject to confirmation by New Zealand Government)

## B. Travel Document Requirement of NZ Resident / Citizens

- A. New Zealand domestic cruises are those which originate and end in ports within New Zealand which do not include a visit to an overseas port outside of New Zealand.
- B. All other cruises are considered to be international cruises. These include (but are not limited to) cruises to Australia, New Caledonia, Vanuatu, Fiji, Tahiti & Asia. New Zealand citizens travelling on international cruises are required to have valid passports.

### Comment/Note:

- As long as they have the 3 criteria they are acceptable. Name photo issuing authority and tamper proof. Note: on domestic cruises Immigration are not interested in processing guests however each NZ port security will check photo ID against ship card prior allowing guest back on board. 18 plus cards are accepted as well as university photo ID and Driver licence is the most common if passports not used. Immigration is covered at airport in and out for international guests on domestic cruises.
- Port security identification

For the purpose of controlling access to ships, port facilities, and port security areas, the following credentials are acceptable for the purpose of establishing identity:

- A military identification card:  
An identification card issued by a New Zealand government department, government agency, or the New Zealand Defence Force
- A driver's licence issued by the New Zealand Transport Agency.
- A seafarer's identity document issued by a contracting government or flag state administration:
- A valid passport:
- An identification credential issued by a port facility operator:
- An identification credential issued by a recognised company, union, or trade association:
- Other forms of identification approved by the chief executive.

Despite subclause (1), the identification listed in subclause (1) is only acceptable if it contains— the holder's full name; and the holder's photograph; and the name of the issuing authority.

The identification must be protected against being tampered with (for example, be laminated).

### Additions to port security identification

From 6 December 2005, Maritime New Zealand will accept the following identification documents for port security identification:

- A credit card with photo.
- Overseas driver's licences (but not International Drivers' Licences) providing they have been issued by a state or central government authority.
- A valid 18+ Identification Card 'Evidence of Age Document'.
